Description of Proposed Change(s): We propose to upgrade the FPGA code in the timing system to eliminate the blinking LEDs during normal operations. The current LED typically have 3 states: off, on and blinking. This will be changed to off, blinking and on. We will also add a diagnostics capabilities to request individual timing boards to blink at a specified frequency.

Reason for Change(s): 0.5Hz and harmonics were seen in the GW spectrum and the blinking LEDs are the most likely culprit.

Estimated Cost: No significant hardware changes.

Disposition of the proposed change(s):
